Efficient waste management system aims at maximal reduce of the waste on the territory of the Municipality of Boljevac. This can be achieved by removal of illegal landfills, sanation and remedial of "Obla" landfill, waste selection and compost and relocation of the remaining waste to the regional sanitation landfill "Halovo".

The entire process includes ecological education of citizens, that is increase of their environmental awareness.

Efficiency of the established waste management system will be proved at the moment when the first ratio on recycled waste is determined having in mind that up to this day the Municipality of Boljevac has not had the chance to recycle the waste — the safest model of environmental protection from surplus waste material.

Better quality of housing hygiene, as well as preservation of land and water eco-systems, means channelling of waste waters to collectors, treatment and disposal into aquifers. This will be done by completion of sewerage network and collector construction.

Functioning of sewerage system would include increasing number of households meaning that increased percentage of waste waters would be treated and aquifers will be protected from further pollution.

A threat of increased deficiency of potable water requires increased water savings as a natural resource. Ecological education on efficient water use, as well as strategic reconstruction of water supply system are necessary and would result in better water supply and reduction of water waste.

The quality of surface waters depends on proper functioning of the system, waste management, efficient and functional sewerage system and ecological awareness of the population.

As a local community responsible to natural resources, the Municipality of Boljevac is determined to protect waters on its territory. Therefore, in the period of strategic goals and activities implementation, special care will be given to development of water basins of the river Zmijanac and Arnauta meaning that the river of Timok will be protected from further pollution.

Since good local communications, but also communication of the local with region and wider areas, depends on good road infrastructure, the Municipality of Boljevac is obliged to permanently maintain its road infrastructure whereas the indicator of the length of roads is significant indicator of realized plans.

Any effort invested to infrastructure maintenance would increase the satisfaction of the citizens of the Municipality of Boljevac, and provide favourable environment and conditions for small and medium sized enterprises development, as well as for development of agriculture and tourism which are the foundations of the growth of this part of Serbia.

The aim of the Local Sustainable Development Strategy part dealing with the Economy is to establish the environment that provides conditions for new job openings, above all, in the private sector in economy, agriculture and services.

Indicators for monitoring the percentage of new jobs, that is percentage of new jobs in all sectors in a given timeframe, will be the proof of objectives realized and indicators of the new situation: established favourable environment for attraction and staying of private investors in the Municipality of Boljevac.

New investments positively influence the increase of employment and strengthening of business and agricultural entities in comparison to close and wider surroundings that directly increases the budget of the Municipality of Boljevac due to taxes paid. This, again, means that the money is returned to the citizens of the Municipality of Boljevac through investments into further development.

Surveys of business entities, BIC beneficiaries, but citizens, too, data on increased satisfaction with conditions for work could be obtained.

Data, such as: number of tourists per year (in relation to the overall population), number of livestock per km² (livestock density) or number of products with protected origin, will be the indicators of successfully implemented programs of economic development of the Municipality of Boljevac.

Share of organic agricultural production will point how much the new technologies are used in production of healthy food making our products more competitive even in the European market.

Every step in planning and realization of programs and projects identified by the Action Plan of the Local Sustainable Development Strategy of the Municipality of Boljevac for the period of 2010 – 2020 is defined so that employment location quotient is increased in the given period, and that municipal fiscal capacity (realization of original revenues) is improved providing thus new foundations for further municipal development – that is providing resources directed further to citizens aiming at satisfaction of their needs for the life in local community.
