

Question No.	Item No.	Clarification Request	Clarification
1.	Lot 2 – Backhoe Loader	It is stated on item 2 that “With Pipework for hydraulic hammer” In order to make clear the situation, we kindly request to give more information. Do you also request hydraulic hammer?	No, the hydraulic hammer is not requested, only the pipework for hammer’s installation.
2.	Lot 2 – Backhoe Loader	It is stated on item 2 that “With all additional equipment that is delivered with the machine” In order to make it clear, please could you specify which equipment do you request? Could you give us more details?	The all additional equipment to be delivered with the machine includes standard equipment like battery, buckets, excavator hand, spoon, tool kit, and everything else that allows machine to be fully functional after the delivery without additional upgrades by the Contracting authority.
3.	Lot 3 – Mini Excavator with a Hydraulic Hammer	It is stated on item 3 that “Hydraulic leaning system of whole upper structure of the machine” There is only one brand which has this system. In order to provide better competition, please could you remove this point from the technical specifications?	After market research during the tender preparation procedure, we learned that there are several manufacturers that deliver the machine with hydraulic leaning or similar system of whole upper structure. Unfortunately, this request cannot be removed or changed at this stage.

4.	Lot 3 – Mini Excavator with a Hydraulic Hammer	It is stated on item 3 that “Machine weight min. 4000kg” In order to make it clear, please could you give us more details about the system? For the machine weight, do you mean Operating Weight or machine weight written on the plate?	“Machine weight min. 4000kg” states for the minimal operating weight of the machine.
5.	Lot 1 – Truck Tipper	On page 3/7 of Supply contract notice in item 15. Period of implementation of tasks you request that period of implementation of the tasks is 60 days from contract signature by both parties. Are you going to let this period to be extended to 100-110 days from contract signature by both parties because this is realistic period which is required for the production of this type of vehicle, and thus to increase competitiveness in this procurement	The deadline of 60 days is selected because it is a procurement of standardized vehicle that does not need any special upgrades and thus the delivery time should not be long. Unfortunately, the period of implementation of tasks cannot be changed at this stage. Also, we let you know that after the Evaluation committee determines the best offer and the Notification of award to the successful tenderer is sent, there is up to 30 days before signing the contract by both parties. Then, the period of implementation of the tasks is 60 days from contract signature by both parties as stated in the timetable of Instruction to tenderers (A. Annex c4b_itt_en).
